SALVAGE FIRM, BUILDING APPRAISAL FIRM, MOTOR VEHICLE REPAIR SHOP, OR ANY

ADJUSTER WHO IS HIRED ON A CONTRACTUAL BASIS BY AN INSURANCE COMPANY
TO REPRESENT THE INSURANCE COMPANY'S INTEREST IN THE SETTLEMENT OF THE
CLAIM. AN INDEPENDENT ADJUSTER IS PAID BY YOUR INSURANCE COMPANY. AN
INDEPENDENT ADJUSTER WILL NOT CHARGE YOU A FEE.
