The foregoing, having been considered by the Court, is hereby:

ORDER:

The court is troubled by the allegations contained in the plaintiff's motion to reargue or reconsider. The court's orders, #107.10, are clear. The court ordered that the parties are to participate in the appraisal process through their designated appraisers, and that "Liberty Mutual shall refrain from engaging in direct communications with the appraisal panel and allow its appraiser to prepare his statement of the loss and let the appraisers identify differences for resolution by the umpire." The court has in no way indicated that if a difference in valuation exists that the parties may then turn the process on its head and turn it into a full trial. The parties are to follow the appraisal process and abide by its rules, including that the parties are to work through their designated appraisers in the process. The court modifies its order #107.10 to include the proposed language of the plaintiff and enters a substituted order.
