CONSOLIDATED ORDER OF LICENSE SUSPENSION

The Georgia Commissioner of Insurance and Safety Fire (hereinafter the "Commissioner"), pursuant to the authority of the Georgia Insurance Code (O.C.G.A. § 33-1-1, *et seq.*) hereby sets forth the following findings of fact, conclusions of law, and order:

FINDINGS OF FACT

1.

The licensee's listed in Appendix A ("Licensees") are currently licensed as Resident Public Adjusters in the State of Georgia.

2.

Effective July 1, 2021, all persons acting directly or indirectly as Public Adjusters in the State of Georgia are required to seek pre-approval of their Public Adjuster services contracts pursuant to O.C.G.A. § 33-23-43.2.

3.

On or around September 29th, 2022, the Commissioner sent Licensees a notice demanding that Licensees submit their contracts for Public Adjuster Services for approval.

4.

The records of the Commissioner reflect that Licensees have not received

approval for their contracts for Public Adjuster services.

CONCLUSIONS OF LAW

1.

Licensees have failed to provide their contract for Public Adjuster services, as

required by O.C.G.A. § 33-23-43.2(a) thereby constituting grounds for the

SUSPENSION of Licensee's Resident Public Adjuster Licenses to transact business in

the State of Georgia pursuant to O.C.G.A. §§ 33-23-21(1); 33-23-21(10); 33-23-43.10(8).

<u>ORDER</u>

WHEREFORE, by the authority vested in me as the Chief Deputy

Commissioner of Insurance of the State of Georgia, IT IS HEREBY ORDERED as

follows:

The Resident Public Adjuster Licenses, held by the Licensees, are hereby

SUSPENDED until the Licensee provides to the Department and receives approval on

their contract for Public Adjuster services, at which time the Licensee may petition that

this Order be lifted. During the suspension, the Licensee shall not perform any activity

for which a license is required by the Georgia Insurance Code or the corresponding

regulations.

IT IS FURTHER ORDERED that Licensees have Fifteen (15) Days from the

execution of this Order to submit a contract for Public Adjuster Services for review that

is compliant with O.C.G.A. § 33-23-43 et seq. Such submissions shall be either emailed

to Compliance@oci.ga.gov or mailed to the Department at Georgia Department of

Insurance, Legal Division, Suite 720 West, 2 Martin Luther King Jr. Drive, Atlanta,

Georgia 30334-9000.

IT IS FURTHER ORDERED that Licensees failing to submit a contract for

Public Adjuster Services for review that is compliant with O.C.G.A. § 33-23-43 et seq.

within Fifteen (15) Days from the execution of this Order are to have their Licenses

SUSPENDED for a MINIMUM of Sixty (60) Days following the submission of BOTH

a compliant contract and a MINIMUM of One Hundred and Fifty Dollars (\$150).

Any Licensee will be afforded a hearing on the issues raised by this Order if and

only if such Licensee's request for a hearing is made within ten (10) days after receipt of

this Order. Failure to request a hearing will constitute a waiver of any provision of law

for a hearing. Licensee must file a written petition with the Administrative Procedure

Division at https://gaoci.govlink.us/oci/license-hearings.
