Results from the petition conference of 8/12/2026

The following list reflects cases on which the court acted at the most recent conference. Set out first are those on which the court (1) acted concerning a petition for rehearing and/or a request for modification of opinion (or elected to grant rehearing or modify an opinion on its own motion); (2) granted a petition for transfer (or elected to transfer a matter on its own motion); (3) granted a petition for review or a request to answer a question of state law (or elected to grant review on its own motion); (4) issued an order to show cause or alternative writ in an original writ matter; (5) granted a request for publication or depublication (or elected to do so on its own motion); (6) dismissed or transferred for reconsideration a granted matter in which further action had previously been deferred, including pending disposition of a related issue in a different case; (7) dismissed or entered an order of abatement in a granted matter or automatic appeal; (8) remanded a matter to the Commission on Judicial Performance or the State Bar for further proceedings; (9) imposed discipline on an attorney; (10) referred to the State Bar a public accusation against any attorney; (11) acted on a clemency matter; (12) acted on any matter in which a justice has authored a concurring or dissenting statement or as to which a dissenting justice wishes their vote to be publicly noted; and (13) acted on any matter in which a justice is recused or not participating. After reporting the disposition of these matters, all remaining matters that were denied by the court are listed in alphabetical order.
